INVITATION TO BID

- 1. The City Government of Malolos, through the Budget for the contract approved by the Sangguniang Panglungsod for 2022, intends to apply the sum of:
 - a. Ninety-Five Million Seven Hundred Thousand Four Hundred Forty One Pesos and 78/100 Centavos (Php 95,700,441.78) being the Approved Budget for the Contract (ABC) to payments under the contract for the Rehabilitation of Malolos Sports & Convention Center, MC Arthur Highway, Bulihan, City of Malolos. Source: 20% Development Fund (Supplemental)

Individual bids received in excess of the ABC shall be automatically rejected at the bid opening.

- 2. The City Government of Malolos now invites bids for the subject bid items. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Projects. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criterion as specified in the Implementing Rules and Regulations of R.A. 9184, otherwise known as the "Government Procurement Reform Act."
- 4. Interested bidders may obtain further information from Atty. Cyrus Paul S. Valenzuela and inspect the Bidding Documents at the address given below from 8:00 in the morning to 5:00 in the afternoon during work days.
- 5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment for the Bidding Documents for all items amounting to Five Thousand Pesos Only (**Php 50,000.00**).
- 6. The City Government of Malolos will hold a Pre-Bid Conference on November 4, 2022 at 2:00 PM at Conference Room, Office of the City Administrator, 2nd Floor, New City Hall Bldg., McArthur Highway, City of Malolos, Province of Bulacan which shall be open to all interested parties who have purchased the Bidding Documents.
