### **INVITATION TO BID**

1. The City Government of Malolos, through the Budget for the contract approved by the Sangguniang Panglungsod for 2022, intends to apply the sum of:
  - a. **One Million Three Hundred Seventy-Five Thousand Pesos (Php 1,375,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Reposting - Purchase of One Unit Motor Vehicle for Service and Site Inspection of Office of the City Architect, City of Malolos, Province of Bulacan. Source: General Fund**
  - b. **One Million Two Hundred Eleven Thousand Seven Hundred Ninety Four Pesos and 32/100 Centavos (Php 1,211,794.32)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Reposting - Installation of Solar Street Lights at City Hall Compound, Brgy. Bulihan, City of Malolos, Province of Bulacan. Source: 2022-20% Development Fund**
  - c. **One Million Seven Hundred Forty Eight Thousand Pesos (Php 1,748,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Provision of High Quality Seeds to Farmers, City of Malolos, Province of Bulacan. Source: General Fund**

Individual bids received in excess of the ABC shall be automatically rejected at the bid opening.

2. The City Government of Malolos now invites bids for the subject bid items. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Projects. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations of R.A. 9184, otherwise known as the "Government Procurement Reform Act."
4. Interested bidders may obtain further information from **Atty. Cyrus Paul S. Valenzuela** and inspect the Bidding Documents at the address given below from **8:00 in the morning to 5:00 in the afternoon during work days.**
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment for the Bidding Documents for all items amounting to **Five Thousand Pesos Only (Php 5,000.00).**





Bids must be delivered on or before **November 15, 2022, 10:00AM** at the **Conference Room, Office of the City Administrator, 2<sup>nd</sup> Floor, New City Hall Bldg., McArthur Highway, City of Malolos, Province of Bulacan**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bids will be opened in the presence of the bidder's representatives who choose to attend bid opening on **November 15, 2022, 10:00AM** at **Conference Room, Office of the City Administrator, 2<sup>nd</sup> Floor, New City Hall Bldg., McArthur Highway, City of Malolos, Province of Bulacan**. In the interest of public health and safety bidders are hereby advised that a maximum of two (2) representatives per company will be accommodated.
